

“Summer Sailing Giveaway” Terms and Conditions

1. Promoter

Lacani, located at 223 Avenue Émile Counord, Bordeaux, 33300, France, is organizing the "Summer Sailing Giveaway" (here and after referred to as "the Promotion") for promotional and advertising purposes. SamBoat is an online boat rental platform connecting boat owners with users interested in renting them. Any questions or comments regarding this Promotion should be directed to: contact@sambo.com

2. Promotion Period

The Promotion runs from 00:00 (midnight) on August 1, 2024, until 23:59 on August 31, 2024 (local time). All bookings made outside of this Promotion Period will not qualify to participate.

3. Eligibility and Entry

- The Promotion is open to individuals aged 18 years, who rent boats on SamBoat and who are residents in any country where SamBoat operates.
- Employees, agents, and affiliates of SamBoat, its subsidiaries, affiliates, and their immediate family members (spouse, parent, child, sibling, and their respective spouses) and household members (whether related or not) are not eligible to participate in this Promotion.
- To participate, eligible participants must book a boat rental through SamBoat between August 1, 2024, and August 31, 2024. Each booking made during this period will automatically be entered into the Promotion.
- The personal data provided by participants must be accurate and truthful.
- Participants may enter the Promotion once with each transaction they do during the period.

4. Winner Selection and Prizes

- The prize for this Promotion is a refund of up to 1.000 € on the total boat rental cost. The effective refunded amount will be determined based on the total cost of the booking made. For example a booking of 500 € will refund a maximum of 500 €, a booking of 1.500 € will refund a maximum of 1.000 €.
- The prize is non-transferable and non-exchangeable, and cannot be substituted other goods or services.
- The winner will be selected randomly between September 7th, 2024, and September 21st 2024.
- The winner will be notified via email within one week of the winner's selection. Suppose the winner does not respond within one week after communication or is found to be ineligible. In that case, the Promoter reserves the right to select an alternate winner from the remaining eligible entries.

5. Limitations and Disqualification

- The Promoter reserves the right to disqualify any participant who violates these terms and conditions or who tampers with the entry process, including but not limited to fraud or cheating.
- The prize is not transferable and cannot be subject to changes, alterations, or compensations.
- The company reserves the right to make changes, extend, or cancel the Promotion for any justifiable reason with prior legal communication.

6. Data Protection & Publicity

- The company responsible for processing your data is Lacani, located at 223 Avenue Émile Counord, Bordeaux, 33300, France.
- By participating in the Promotion, participants agree to allow Lacani to process their personal data for the purposes of administering the Promotion, including contacting participants and verifying their eligibility.
- The participants are hereby informed that their personal information will be treated and used with the following objectives: contacting winners and processing refunds.
- The company will only process personal data in accordance with applicable data protection laws.
- Participants may have the right to request access to, rectification, or erasure of their personal data or to restrict or object to its processing.
- Any personal information collected from participants in the Promotion will be used in accordance with the Company's privacy policy [[link to privacy policy](#)].

7. Discharge of Liability

- By participating in the Promotion, participants agree to release, discharge, and hold harmless the company, its affiliates, subsidiaries, advertising and promotion agencies, and their respective officers, directors, employees, and agents from any and all liability, loss, damage, or injury arising out of or related to participation in the Promotion or the acceptance, use, misuse, or possession of any prize received through the Promotion.
- The Promoter shall not be liable for any direct, indirect, incidental, special, or consequential damages arising out of or in any way connected with the Promotion.

8. Amendments

- The company reserves the right to modify or extend these promotional bases, to the extent that it does not harm or impair the rights of the participants in the Promotion.

9. Governing Law

- These terms and conditions shall be governed by and construed in accordance with the laws of Bordeaux, FR. Any dispute arising out of or in connection with the Promotion or

these terms and conditions shall be subject to the non-exclusive jurisdiction of the courts of Bordeaux, FR.

- Suppose any provision of these terms and conditions is found by any court or competent authority to be invalid, unlawful, or unenforceable. In that case, that provision shall be deemed to be deleted from these terms and conditions and the remaining provisions shall continue in full force and effect.

10. Agreement
